### Message from Barb Whinery, Chair Leadership Council

Two of our longtime members were volunteering at an event this summer promoting the League and sharing the possibilities of membership with attendees and other organizations present. They reported back to me that many of the people that attended the event said that they had not heard of League nor did they know what we do. Wow, that was a real wake-up call to me as I have taken it for granted that everyone must know about our organization! And what we do! We have some work to do!!!

While many leagues go into hibernation and take the summer off, that has not been the case with the Greeley/Weld League. Our summer events included several events and League programs:

- **A Pro/Con Forum on Amendment # 69 (Single Payer Healthcare for Colorado)** was a huge success and was a model of what League does when presenting arguments for and against a ballot issue.

- **Two League programs** were presented at member meetings. The first discussed **League Election activities** during the election season that includes voter registration, ballot issue education and candidate forums. The second outlined and presented materials on the **League Observer Corps** that keeps an eye on local boards, committees and commissions. Each provided training for members to participate in things League does.
- Your Greeley/Weld League had five members who participated in the **LWVCO Leadership Retreat** in Frisco this summer. Our local Finance Drive Committee was hard at work updating a contributors mailing list and designing an outstanding letter to solicit contributions to help us in our endeavors. Three members were trained to support our involvement in putting our local county commissioner election on Vote411.org. Lastly, we had a great time at our Fall-Kick-off picnic at the home of Shirley Prom & family!

As you can see we are preparing for an active role election season where the League can have high visibility to better educate our community on voting and ballot issues in addition to who we are and what we do. Upcoming voter education events will include voter registration at Aims CC and participation in National Voter Registration Day at a Windsor Library, ballot issue presentations and education programs about issues in Greeley.

**Member meetings are on third Thursdays of each month from 6:00 p.m. – 7:30 p.m.** I am challenging our members to attend member meetings, events, and to volunteer where and when you are able. Also it time to take the opportunity to be ambassadors by talking to friends, family and members of the community about the League.

## **Affordable Housing Summary**

The topic of the LWV Greeley/Weld October meeting was affordable housing in the Greeley area. We had a panel of four speakers who introduced us to the issues, projects and future plans to deal with homelessness and more affordable housing in our community. This is not just a Greeley issue, but also one that is prevalent across the state.

Melanie Falvo, Director of Community Impact from the United Way, provided an overview of what her organization is doing to facilitate conversations in Greeley and the county to meet affordable housing needs. She presented statistics on who experiences homelessness. There are 100+ homeless veterans on the Weld County Veterans Administration wait list. Of the individuals who are homeless, 25% have been homeless for 12 months and have a disabling condition. According to the State Department of Education there were 1,013 homeless students in Weld County during the 2014-15 school year. And the number of families in Weld County who need more affordable housing is 3,800+. To address these needs United Way is developing a countywide plan for maximizing resources dedicating to serving those who are homeless, involving neighbors to help each other during hardship, and uniting community members for lasting change. The plan is called Weld's Way Home. The plan includes eight study areas to examine the issues and making recommendations for action.

Cheri Witt-Brown, Executive Director, Greeley Area Habitat for Humanity, spoke to us about what they do, projects completed and plans for the future. They work in partnership with the whole community and are able to build seven homes per year. One of the latest projects was to build a home for a veteran and his family in Hudson. In the next 30 years they hope to build 120 homes. She also talked about collaborations they have with the Jefferson High School and the School District #6 Pathways Program.

Enita Kearns-Hout, Regional Director of Catholic Charities in Weld County, from the Guadalupe Community Center, shared the need for the services, an overview of the services the center provides and plans for future. According to recent data, more than 250 people are in need of permanent housing in Weld County, half of which are under age 25. The Center provides overnight emergency shelter, transitional housing shelter, daily meals, case management and referrals, medical support and a computer resource room. She was most excited about the 47

unit Guadalupe Apartments the Center is building. The apartments will provide 10 two-bedroom units, 19 one-bedroom units and 18 studio apartments. This facility will serve homeless families and people, providing them supportive services such as employment resources, case management and mental health referral.

Tony Gregor a local resident with an interest in providing affordable housing in the community spoke to us about his ideas using tiny house/cottages project. He felt that we had to change the way we think about building less costly housing perhaps as low as \$50,000.

There will be future opportunities for the League to participate in a study group, be part of local committees and to advocate for state legislation on affordable housing. The Larimer LWV has a team who is studying the issue in their county, too. Please let Barb Whinery know if you would like to participate in looking for strategies to improving our homelessness and affordable housing concerns.

The general requirement of the law is that "all meetings of public bodies shall be open to the public at all times." As an observer, you are exercising that recognized right to be present at any public meeting.

### Responsibilities for Observers :

- Attend assigned meetings, wearing a large LWV pin. (You don't have to attend every meeting—4-6 a year would be terrific.)
- Complete an observer form and advise the board of opportunities for action on League positions.



Being an observer can be interesting and fun. It puts the League on the inside, hearing decisions that will affect the community/state and the League.

Currently, we have League members that regularly attend the Greeley City Council meetings and the High Plains Library District Board meetings. We are especially interested in having a presence at Weld County Commissioner and Weld School District 6 Board meetings, but if you have interest in other local government meetings--town councils, Planning Commission, water districts, etc.-- please come forward.

The County Commissioners generally meet on Mondays and Wednesdays starting at 9:00 a.m. at the Administration building, 1150 O Street in Greeley.

The District 6 Board meets the second and fourth Mondays of the month, usually at the District 6 Administration Building, 1025 Ninth Avenue, in Greeley. Work sessions begin at 4:00 and the regular board meetings begin at 7:00 p.m. The regular meetings are streamed and can be viewed online live or at a later date at <http://www.greeleyschools.org/Page/14907>.

## **POLICE PRACTICES IN GREELEY**

On November 17, 2016, Greeley Police Chief Jerry Garner spoke to the Greeley/Weld League members and community members. The mission of the



Greeley Police Department is ***to maintain, improve, and protect the quality of life in Greeley. He listed four goals for the Department:***

1. To take career criminals out of circulation;
2. To decrease traffic accidents (the judicious use of traffic tickets helps reduce accidents);
3. To provide exceptional professional service to the public;
4. To provide police officers that are role models on and off duty.

The transient population has increased in Greeley, Chief Garner stated, and as a result the Greeley Police Department needs to work even more closely with mental health resources in our city and county, particularly North Range Behavioral Health. A representative from North Range present at the meeting agreed. There were about 25 League members and interested community members at the meeting.

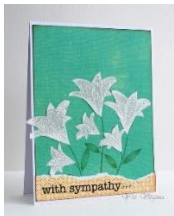
